#### D. Board Minutes

-The September 16, 2025 Board Meeting Minutes were reviewed by the Board.

The following amendments to the minutes were reviewed by the Board:

## **G.** Volunteer Association

- -Chief Joe Kaczenski informed the Board that the Columbia County Volunteer Association meeting was hosted at MBRFPD on October 13<sup>th</sup>.
  - NW Natural was unable to give the CCVA a brief overview of their facilities.
  - MBRFPD gave a detailed look into their Animal Technical Rescue equipment, training, and responses.

### H. Unfinished Business

- -Training Division Chief Will Steinweg said there was no FEPP update.
- -Chief Kaczenski has finished the additional measurements for the preliminary drawings but they have not been given to the engineering contact.
- -Training Division Will Steinweg has contacted R&R Towing regarding the used training vehicles, and they will be removing them.

A motion was made by Director Rene Armstrong to approve Policy 1310, Whistleblower Protections as presented. Director Paul Ramsey seconded the motion. Directors Pamela Owen, Paul Ramsey, Rene Armstrong, Diana Keeney and Larry Boxman gave a yes vote. The motion carries.

### J. Correspondence

-Vernonia RFPD sent a Thank You card for writing the FEMA Turnouts Grant that was awarded to both MBRFPD and Vernonia RFPD.

### **K.** Committee Reports

-A Workplace Health and Safety Committee (WHaSC) update was given by Fire Chief Joe Kaczenski. October is station inspections. The next WHaSC meeting will be held on November 4<sup>th @</sup> 9 a.m.

- -Director Larry Boxman asked for suggestions about how to move forward with the Community Task Force data that has been compiled. Some of the suggestions are as follows:
  - Refer back to data when making decisions
  - Send something out to community showing the data and how the Fire District is responding
  - Relay to community that some of the things they suggest, the Fire District cannot afford to implement (i.e.: 24/7 professional emergency coverage)
  - Showcase to the community who the volunteers are and what their credentials are
  - What would the professional compensation be for what our volunteers do?
  - Showcase to the community the training that is given/needed
  - Produce an annual report
  - Showcase to the community conflagration deployments and the money this brings in
  - Showcase to the community the grants that have been applied for and awarded

#### L. New Business

-Training Division Chief Will Steinweg asked the Board for approval to spend the FEMA Firehose Grant money plus the 5% buy-in by MBRFPD.

A motion was made by Director Larry Boxman to approve the spending of the FEMA Firehose Grant money plus the 5% buy-in by MBRFPD for a total of \$71,998.21. Director Diana Keeney seconded the motion. Directors Pamela Owen, Paul Ramsey, Rene Armstrong, Diana Keeney and Larry Boxman gave a yes vote. The motion carries.

-Training Division Chief Will Steinweg asked the Board for approval to spend the FEMA Turnouts Grant money.

A motion was made by Director Larry Boxman to approve the spending of the FEMA Turnouts Grant money, up to \$180,000. Director Rene Armstrong seconded the motion. Directors Pamela Owen, Paul Ramsey, Rene Armstrong, Diana Keeney and Larry Boxman gave a yes vote. The motion carries.

-Fire Chief Joe Kaczenski suggested the Board adopt the new 2025 Oregon Fire Codes.

A motion was made by Director Larry Boxman to adopt the new 2025 Oregon Fire Codes. Director Paul Ramsey seconded the motion. Directors Pamela Owen, Paul Ramsey, Rene Armstrong, Diana Keeney and Larry Boxman gave a yes vote. The motion carries.

-Director of Administrative Resources Marianne Berg reminded the Board of the upcoming OFDDA Annual Conference being held in Seaside Oregon November 20<sup>th</sup> - 22<sup>nd</sup>.

Training Division Chief Will Steinweg asked the Board for approval to purchase a vehicle for the Fire District.

A motion was made by Director Paul Ramsey to approve spending up to \$40,000 on a vehicle for the Fire District. Director Larry Boxman seconded the motion. Directors Pamela Owen, Paul Ramsey, Rene Armstrong, Diana Keeney and Larry Boxman gave a yes vote. The motion carries.

-Training Division Chief Will Steinweg asked the Board to surplus Utility 463.

A motion was made by Director Rene Armstrong to surplus Utility 463. Director Diana Keeney seconded the motion. Directors Pamela Owen, Paul Ramsey, Rene Armstrong, Diana Keeney and Larry Boxman gave a yes vote. The motion carries.

-Director Rene Armstrong thanked everyone for making the budget work with the funds available.

- -Chief Kaczenski reminded everyone that the weather is beginning to turn and to watch for shaded corners on the roads.
