MBRFPD has been contacted to see if they still have the abandoned motor and the water tender it resides in. Chief Steinweg told them the Fire District does still have it and if they want the motor and tender, it's theirs. Chief Kaczenski commented that this water tender was surplused awhile back. Chief Steinweg is waiting for FEPP to give the Fire District an inventory of what FEPP items MBRFPD has.
